# City of Palouse COUNCIL MEETING MINUTES

Tuesday, April 9, 2024

Note to persons reviewing this document: This is not a verbatim transcript. While an attempt has been made to document pertinent points, these minutes contain only a summary of the discussion and voting.

**CALL TO ORDER:** Mayor Sievers called the meeting to order at 7 PM

Councilmembers\* present at the meeting were Angie Griner, Leslie Jo Sena, Molly Quigley, Robert Brooks, and Ann Barrington.

I. ROLL CALL: DC Gaber took attendance; C. Bofenkamp and C. Anderson were absent.

C. Sena introduced a **MOTION** to excuse C. Bofenkamp and C. Anderson's absences from the meeting; the **MOTION** was seconded by C. Barrington. All council members approved, and the **MOTION** passed.
